UNDER DEPARTMENT HEAD REPORTS: ELECTRICAL DEPARTMENT SUPERINTENDENT JIM MOREHEAD REPORTED ONE OVERTIME DUE TO WEATHER OUTAGES. DILLER ELECTRIC HAS COMPLETED THE ELECTRICAL HOOK-UPS FOR THE CAMPING PEDESTALS AND ROADS AND CAMPING AREAS ARE BEING GRADED AND LEVELED AT CRYSTAL SPRINGS; CONTRACT WITH LICENSED ELECTRICIANS TO WORK ON SCOREBOARDS; CONTINUE WITH PROJECTS AT THE BRICKYARD. WATER SUPERINTENDENT JEFF SWEETSER REPORTED ONE OVERTIME DUE TO RESPONDING TO A REPORT THAT A GATE WAS OPEN AT THE SEWER PLANT – CLOSED GATE. REPAIRED WATER LEAK AT EAST WELL CHLORINE INJECTION PUMP; COMPLETE4D DIRT WORK AT DEMOED HOUSES; TAKING WATER SAMPLES; CHANGED PREFILTER AT FILTRATION PLANT AGAIN – TWO WEEKS USE; TESTING LAB/OLSSON & ASSOCIATES PREPARING PROCEDURES TO ADDRESS THE BIOFILM THAT IS CLOGGING THE FILTERS; WATER USEAGE FOR THE PREVIOUS WEEK WAS 1,033,000 GAL/DAY.
