UNDER DEPARTMENT HEAD REPORTS: ELECTRICAL DEPARTMENT SUPERINTENDENT JIM MOREHEAD REPORTED ONE OVERTIME DUE TO POWER OUTAGE FROM FALLING TREE LIMB AT 1325 H ST. SIDE-BY-SIDE SPRAYER RENTED; TRIMMING TREES; SPRAYING; HAULING POLES FOR LINE RECONSTRUCTION; LEVELING GROUND AROUND CAMPING SITES AT CRYSTAL SPRINGS; WILL BE TESTING TWO SUBSTATION TRANSFORMERS THIS YEAR – YEARLY TEST; STILL WAITING ON TRANSFORMER ARRESTORS FROM SOLOMON; CHECKING INVENTORY; WORKING ON PROJECT BUDGETS. WATER SUPERINTENDENT JEFF SWEETSER REPORTED NO OVERTIME. WATER TREATMENT PLANT IS SHUT-DOWN DUE TO RECURRING FILTER CLOGGING PROBLEM; ALL WATER WILL BE PROVIDED THROUGH THE EAST WELLS ONLY; CHEMICALS TO ADDRESS THE FILTER PROBLEMS HAVE BEEN ORDERED; RECONSTRUCTED NEW 8” MAIN AT TREATMENT PLANT; ALL DIRT WORK DONE AT CRYSTAL SPRINGS AND SEEDING IS IN PROGRESS; WATERING TREES AT CRYSTAL SPRINGS; HOOK-UPS FOR TWO HOUSES CONSIDERED; WATER USEAGE FOR THE PREVIOUS WEEK WAS 1,342,000 GAL/DAY.

MS. RENN REPORTED THAT THERE WILL BE A VIRTUAL MEETING ON THE WATER/STORMWATER PROJECT; NO UTILITY SHUT-OFFS FOR THIS WEEK.

MS. RENN REVIEWED FINANCES WITH THE BOARD. OUTSTANDING ACCOUNTS WERE PRESENTED.
