UNDER DEPARTMENT HEAD REPORTS: WATER SUPERINTENDENT JEFF SWEETSER REPORTED OVERTIME FOR WATER LEAK AT 826 HUBBEL ST. CONCERNING THE ISSUE WITH THE FILTERS AT THE TREATMENT PLANT, CRAIG REINCSH OF OLSSON AND ASSOCIATES IS PREPARING A LETTER TO THE STATE DEPARTMENT FOR A PILOT PROGRAM TO STUDY THE PROBLEM FOR A PERIOD OF SIX MONTHS INVOLVING CHEMICAL INJECTION OF THE WELL WATER PRIOR TO THE WATER REACHING THE FILTERS IN AN EFFORT TO ERADICATE THE BUILDUP OF BIOFILM ON THE FILTERS. THE DEPARTMENT OF HIGHWAY CONSTRUCTION OF CULVERTS ON HWY 15 BURIED A MANHOLE WHICH WILL HAVE TO BE EXCAVATED AND THE MANHOLE RAISED; CONTINUING THE COLLECTION OF LEAD/COPPER SAMPLES; CABLES ARE INSTALLED AROUND THE NEW CAMPING SITES; WATER USEAGE FOR THE PREVIOUS WEEK WAS 1,081,000 GAL/DAY.

MS. RENN REPORTED THAT THE ELECTRICAL DEPARTMENT IS SHORT-STAFFED THIS WEEK AND HAS BEEN WORKING ON OUTAGES CAUSED BY WIND RECENTLY. ALSO, THE MAIN OFFICE WILL BE OPENING THIS COMING MONDAY.
