RE: Results of lead screen testing on 02/10/2023.

Laura,

I am enclosing the results of the lead-based paint screen testing conducted on 02/10/2023. The window sill, floor and paint chip composite samples taken from the property have **failed** the clearance test and were found to be **above the regulatory limits**. The clearance levels set by U.S. Department of Housing and Urban Development (HUD) are 10 micrograms ( $\mu\text{g}$ ) of lead in dust per square foot ( $\mu\text{g}/\text{ft}^2$ ) for floor dust and 100  $\mu\text{g}/\text{ft}^2$  for window sill dust, and 5,000 pb ( $\mu\text{g}/\text{g}$ ) ppm for paint chip samples.

The floor composite samples collected from the property were found to be at 1,230  $\mu\text{g}/(\text{ft}^2)$ , while the window sill composite samples were measured at 4,190  $\mu\text{g}/(\text{ft}^2)$ , which are both above the permissible limit. The lead-based paint chip samples collected from throughout the house interior and exterior were also found to be above the limit at 60,000 pb ( $\mu\text{g}/\text{g}$ ) ppm.

## Summary of Findings

### Background Information

The property is located in a flood plain and is potentially being bought by the City to demolish the building. The lead screen test was conducted as a condition of the program.

### Hazard Reduction

None at this time.

### Visual Assessment

A visual assessment of the structure on February 10th, 2023, indicated that there were areas of deteriorated paint, visible dust, debris, residue, or paint chips around the exterior or interior of the property.

### Dust Samples

Individual dust wipe samples were collected from floors and interior window sills. **The wipe composite floor and sill samples contained lead-in-dust above the allowable limits.**

Therefore, the unit **failed** the screening examination. See Field Sampling Form for Dust for the results of all dust samples. Copies of the Wipe Lead Analysis Summary are attached.

### Soil Samples

No soil samples were taken.

### Corrective Action

The US EPA has stated that solid architectural components coated with LBP are less likely to be hazardous because of the small ratio of lead paint to total waste mass. The US Army conducted a study which concluded that whole-building demolition debris is not likely to exceed the toxicity characteristic standard for lead if it is handled as a single, whole waste stream and disposed of all together. Whole-building demolition debris is therefore considered a non-hazardous waste with regard to lead. This has been verified with Douglas Gillespie from DHHS for the state of Nebraska.
